Subject: Amendment to Fiscal Year 2014 Audit Plan

INTRODUCTION

The aim of the City's Performance Audit program is to improve the efficiency, effectiveness, and accountability of City service delivery, and to reduce risks. The Berkeley City Charter requires that the City Auditor provide the City Council with a planned audit schedule by the beginning of each fiscal year.

On July 16, 2013, the Audit Plan for the current fiscal year was presented to Council. As required by the City Charter, we are notifying Council of a modification to the annual audit plan. We are adding a refuse billing audit to the FY 2014 annual audit plan to determine whether refuse billings match subscription levels.

- Refuse billing audit As a tie into our current Zero Waste audit, a refuse billing audit will help identify improperly billed accounts in Zero Waste programs. We will statistically quantify billing discrepancies for the refuse fund.

Deferred to 2015

 Permit Center Phase II: Use Permits – Deferring this audit will allow us to consider the effects of Planning's implementation of the recommendations in our 2014 audit.

BACKGROUND

Performance Audit's goal is to improve the efficiency, effectiveness, and accountability of City service delivery, to reduce the risk of loss, and to promote ethical governance.

FISCAL IMPACTS OF POSSIBLE FUTURE ACTION

Audit work can lead to new revenue, cost recovery, and increased efficiency, with economic impact well beyond the audit costs. Long-range financial benefits of the audits completed in FY 2014 should result in significant improvements to internal controls and improved efficiency and effectiveness of Citywide services.

The action Council takes to ensure timely action on all audits should result in additional savings and risk reduction, including fraud risk. Reducing fraud risk does more than save money; it helps build trust in government. Maintaining a strong audit function and prudent fiscal and program management will reduce future costs and enhance public trust.
