We revised the landscape elevation per your comment. Is it ok to replace the drawing set in the Box? Let me know how you want me to handle this. Thanks.



All outstanding items below are satisfied and we are looking at our upcoming Design Review Committee agendas in conjunction with the Use Permit scheduling. Ashley or I will be back in touch with more specific scheduling information on the DRC meeting. Raju - I just looked at the drawings again, and the landscape elevation (west) is the one that has the wall signage lower than on the architectural elevations. All other drawings appear to be consistent. Again we are not holding up any scheduling or reviews on this, but if this could be corrected before you print copies for the DRC meeting, that would be best.

Hello, Raju: We were able to go through your design review application for the proposed parking garage at the above address. Thank you for the detailed information that you've already included in this application, but we do still need additional information before we can continue our review.

- Although we do see the before and after renderings provided on Sheet A115, the views provided on both Fourth and Fifth Streets are only from one direction. Please also provide a rendering in the other direction with the adjacent building shown for context. **Satisfied.**
- Provide a more detailed analysis of how this project will fit within its neighborhood, including any key building elements on nearby structures proposed to remain that this structure is relating to. **I did read in your Zoning Response Letter that you intended to attach a response for our Design Review questions, but I was not able to locate that response. Please re-send it directly to me. I am looking forward to going through that information.**
- Consider any possible increase in landscape material in front of, on the face of, and on top of the most visible facades (Fourth, Fifth, North) to help soften and fit this project into its neighborhood. When submitting any revised landscape plans, also submit a revised preliminary plant palette. **Satisfied.**
- Street trees – we see where street trees are shown on Fourth Street, but not Fifth. For any streetscape improvements on both Fourth and Fifth, please consult with Public Works, the Urban Forestry Division, and Land Use Planning Consultant. **Please provide an update on any recommendations that you have found on both street frontages for street trees and associated streetscape improvements.**
- A related issue with proposed streetscape is the raised planter notes on the Public Right-of-way on the Fifth street side of the project. This should also be reviewed early on with Public Works. **Please provide an update on any recommendations that you have from Public Works on any encroachments proposed on both street frontages.**
- Your project description notes a secured amenity space on the northwest corner of the site. Please provide more detailed information about the layout of this amenity space and how it meets the street and is secured

when not in use. We have the term 'parklet' for the creation of seating areas on our Public Right-of-way in the parking lanes. We recommend that you rename this space so there is no confusion. **Satisfied.**

- Provide detailed color and material information, as well as detailed wall sections, especially on the Fourth, Fifth and North elevation that are so visible. **Thank you for the details wall sections. We will want more detailed color and material information when this is reviewed with the Design Review Committee, but this will not hold up any scheduling. We will coordinate with you on this issue as we move closer to a public meeting date.**
- Larger blade signage is shown on Fifth Street, but not on Fourth. Building signage is shown on Fourth at the pedestrian entrance/exit. Consider this signage in more detail as it is a significant design element and should be more flushed out when you come to the Design Review Committee. **While we do see more resolution on the overall design concept, there is a discrepancy between several of the renderings and elevations as to the location of the wall sign on the west elevation. Clarify this in your resubmittal and amend any renderings and elevations needed.**

Thank you again for the information and detail to date. Please reach out to me directly if you have any questions on the list above. I will work with your Use Permit Planner, Ashley James, to review any resubmittals and will coordinate our scheduling with her. Thank you. – Anne Burns, Design Review Planner (510) 981-7415
