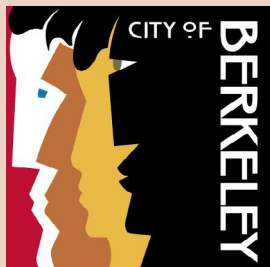

**Building Move
Permit Submittal
Requirements:**

- *Site Plan*
- *Photographs of all sides of the structure to be demolished*
- *Map of proposed building move route showing potential obstructions*

Authorization:

The applicant is responsible for acquiring all signatures and submitting all documents prior to review, approval, and issuance of the building move permit. Steps 1-2 must be submitted sequentially before acquiring signatures for steps 3-10.

Plans and supporting documents must be submitted in electronic format as unsecured, flattened PDF(s) with embedded fonts. Min 11"x17" sheet size.

	Reviews route. Assigns time of the building move. Must be stamped and signed. <u>Note:</u> Traffic Engineering will review and edit customer's ROUTE MAP, which must be presented at each agency to acquire signatures.

	Engineering will approve sewer capping at the original address. Obtain standards for sewer capping from Engineering Inspector.

	Applicant must have written proof from PG&E that all gas and electric service has been disconnected. Engineering will verify that PG&E's documents were presented.

	Applicant must secure NO PARKING signs and STREET USE PERMITS to be placed along the entire route, wherever needed, so that parked cars will not impede the moving of the building. The number of signs required will be calculated by engineering.
