

#### **AB 2923 Overview**

- Enacted September 2018 Public Utilities Code Section 29010
- Law sets baseline zoning standards for BART-owned property
- Allows BART to adopt more intense standards, but not less
- Currently BART intends to "default" to baseline standards
- Berkeley will have until July 1, 2022 to adopt zoning that conforms with these standards



# "Urban Neighborhood/City Center" Zoning Must Allow...

Residential Density	At least 75 units per acre
Building Height	7 Stories
Residential Parking	No Minimum, 0.5 spaces per unit max
Office Parking	No Minimum, 1.6 spaces per 1,000 sq ft max
Floor to Area Ratio	4.2



# What is Floor-Area-Ratio (FAR)?

FAR is the size of building compared to the land area.

The example below shows possibilities with a 3.0 FAR.





- Ridership gains preferably at times BART has capacity (outside of peak window)





### Financial feasibility and project delivery

- Achieve at least 35% affordable housing
  - BART's new policy to discount land for affordable projects by up to 60%
- Developments must be financially and economically feasible
- Complete developments within 5 years of receiving city planning approvals
  - Assuming healthy economic activity and financial conditions





### Infrastructure needs, costs and viability

- New BART infrastructure to accommodate development:
  - Reconfiguration of BART access infrastructure
  - Parking replacement costs
  - Station enhancements and modernization, such as:
    - Vertical circulation (Stairs, escalators, elevators)
    - Ventilation
    - Faregates
- Other development infrastructure:
  - Public/civic spaces
    - Capital costs
    - Operations & maintenance costs






### Parking replacement considerations: Access Trends


#### **Ashby**

#### **North Berkeley**


- Avg. drive/park distance: 1.37 miles
- Fill time (pre-COVID): 9:30 AM





### Parking replacement considerations: Tradeoffs

- Balancing access to the station with TOD goals
- Parking replacement costs:
  - \$60,000-\$80,000/space to build a parking garage
  - For example: 50% parking replacement at North Berkeley would cost ~\$28 million
- Limited funding sources
- \$\$\$ spent on building structured parking means less money and space for:
  - Affordable Housing
  - Residential Density (important for activation/retail)
  - Civic Space and landscaping/urban design elements
  - Transportation Infrastructure Improvements
  - Community-serving uses (child care, etc.)
  - Other Community Benefits












