

Proposition 218 Procedures and Five Year Zero Waste Rate Schedule

April 25, 2023



Programs/Services over 5 Years

- Preconstruction Costs for Transfer Station Replacement
- Ecology Center, Community Conservation Center, and other contracted services
- Stormwater Compliance at Transfer Station
- SB 1383 Compliance (unfunded mandate)
- Vehicle Replacement & Maintenance
- Ordinance implementation Single Use Foodware and Plastic Bags
- Road Maintenance due to impacts of heavy collection vehicles
- Make ZW customers eligible for City's Very Low-Income Refund Program

Updates Since February 28 Work Session

- Revised rates for 64- and 96-gallon containers to match cost of service
- Updated Other Fees, e.g., distance charges, extra pickups, container cleaning
- Added responses in staff report to questions raised at work session, e.g., tons landfilled over time, citation revenue, etc.
- Included ordinance amendment re: Very Low Income Refund Program
- Included in tonight's packet a rate alternative that reduces rate increases by removing \$7.0 million in costs related to heavy vehicle impacts on road maintenance

One residential rate for all 3 services

Separate rates for commercial customers

- Refuse/Recycling (includes 1x per week recycling collection)
- Organics (required by SB 1383)

- Residential rates are well below the cost-of-service
- Commercial rates need a slight increase to keep up with rising costs

- July 1, 2023 rate increases if COS re-alignment is transitioned all in Year 1
- HF&H and staff developed a phase-in approach to reaching COS for small containers

Staff recommends phased-in Cost of Service approach

- Phase-in rate increases to smaller containers to reduce steep rate increases
 - Maximum annual increase of \$6.00 per month per year
- Current rates which exceed their COS are reduced to COS
- Fund Balance is used to allow this phased-in approach
- Small container rates will be closer to, but not reach, the full cost-of-service by FY 2028 under this scenario
- Includes \$7.0 million in Road Maintenance expenses


- Table reflects most-common subscription levels; represents 62% of commercial/multi-family customers
- Solid Waste rate includes 1x/week recyclable material collection -Organic collection charged separately based on customer needs
- Current rates are very close to their COS 0.4% increase for FY 2024 is necessary

City Council Action

- Staff Recommendation
 - Phase-in COS rates maximum \$6/month increase to residential rates
 - Funds \$7.0 million in Road Maintenance expenses
- Rate Alternative
 - Phase-in COS rates maximum \$4.50/month increase to residential rates
 - Does not fund \$7.0 million in Road Maintenance expenses
- Take no action
 - Compliance risks with SB 1383, stormwater regulations, etc.
 - Slows down local foodware/plastic bag ordinance implementation and fleet electrification/replacement
 - Staff will return in FY 2024 with service reduction options to ensure the Zero Waste Fund remains financially viable

Next Steps

- 4/25 Seeking City Council approval:
 - to initiate Proposition 218 process
 - to make ZW customers eligible for City's Very Low Income Refund Program (\$100,000 in General Funds needed, revise ordinance)
- If approved, City staff mail notices to ratepayers with proposed rate schedule no later than 5/12. Notice includes rates for next five-year period.
- 6/27 City Council can approve rates if no majority protest occurs
- 7/1 New rates go into effect; process to update billing may take longer

Q&A

- Zero Waste Strategic Plan and various initiatives, e.g., biweekly trash pickup, no trash pickup, elimination of 64- or 96-gallon containers, etc.
 - Maximum" rates, "migration" and lowered costs
- Proposition 218 majority protest procedures
