Meeting Purpose

PY 2024 (FY 2025) Annual Action Plan

- Conduct a Public Hearing. Solicit community input on the Draft Annual Action Plan.
- Adopt the PY 2024 (FY2025) Annual Action Plan. Including all federal allocations to community agencies.

Community Agency Request for Proposal

 Review & Solicit Community Input on City Manager & Review Body Recommendations. Including all funding source allocations totaling estimated \$10.9 million/year through the City's FY 2025–2028 community agency request for proposal (RFP).

PY 2024 (FY 2025) Annual Action Plan

Public Hearing

U.S. Department of Housing and Urban Development (HUD) allocates the following grants to the City of Berkeley:

- The Community Development Block Grant (CDBG) Entitlement Program provides grants to entitled cities and counties to develop viable urban communities for low- and moderateincome persons.
- The Emergency Solutions Grants (ESG)
 program provides grants to help people quickly
 regain stability in permanent housing after
 experiencing a housing crisis and/or
 homelessness.
- HOME Investment Partnerships Program (HOME) provides grants to state and local governments to create affordable housing for low-income households.

City of Berkeley receives HUD grants and is required to:

- Prepare and submit a 5-year Consolidated Plan.
- Prepare and submit an <u>Annual</u>
 <u>Action Plan (AAP)</u> for each of the 5years within the Consolidated Plan
 period.
- Include community input and participation throughout.
- Prepare and submit a Consolidated Annual Performance and Evaluation Report (CAPER).

FY 2025-2028 Community Agency RFP Context

- Every 4 years the City issues an RFP inviting community agencies to apply for Federal, State, Local, and/or General Fund dollars.
- Largest coordinated ongoing investment by the City to meet its strategic goals to address critical health, housing, well-being and equity issues affecting Berkeley's most vulnerable populations.
- Impact of these investments is achieved through strong community agency partners and partnerships.


