Internal Addendum "B"

Questions and Answers for Specification No. 22-11515-C Marina Finger Dock Construction

The City of Berkeley has received questions from some potential respondents regarding **Specification No. 22-11515-C**, **Marina Finger Dock Construction**. In an effort to provide the same information to all, listed below are the questions received to date, with responses from City staff.

- 1.Q. Addendum A specifies that all responses should be sent via email to purchasing@cityofberkeley.info. The previous Invitation for Bid document specified that bids were to be mailed or hand delivered, received no later than 2:00pm on June 14, 2022. Can you please confirm that the submission method has been updated to email only, with receipt by 2:00pm on June 21, 2022?

 1.A. Please follow instructions on Pg.1 of this Addendum "B".
- 2.Q. Addendum A specifies that bidder should submit (1) PDF of the technical proposal, and corresponding cost proposal as a separate PDF document. The technical proposal is not described in the original invitation for bid documents. Can you please identify what is to be included in the technical proposal?
- 2. A. That incorrect verbiage in the cover letter for Addendum A is for a different process and does not apply to this IFB. Proposals/Bids consist of the documents listed in Section F of the IFB.
- 3. Q. Can you please post the pre-bid sign-in sheet from May 12, 2022 and June 1, 2022?
- 3. A. See attachments 1 and 2.

Clarifications for specification 22-11515-C Marin Finger Dock Construction

Bid Item 1: Shall hereby include **only** replacement of existing walers on 52' dock with new walers, cleats, rubber strips, and pile ring. Leveling of existing concrete floats. This includes both finger docks K106-108 and K114-116.

Bid Item 2 & 4: Includes removal and re-installation of dock gate/security fence.

Bid Alternate Item 1: Shall hereby include **only** replacement of existing walers on 65' dock with new walers, cleats, rubber strips, and pile ring. Leveling of existing concrete floats. This includes **only** the eastern most finger dock K147.

Bid Alternate Item 2: Shall hereby **only** include a complete replacement of the entire concrete finger dock with a new 4' x 65' concrete finger float section including new walers, rubber strips, cleats, pile ring, and disposal of old floats. This includes **only** the K143/144 finger dock.

Bid Alternate Item 4: Shall hereby include only replacing the last 4' x 8'concrete float section against the pile ring. This will include all new walers, rubber strips, cleats, pile ring, and disposal of old float.
