Incomplete applications will not be processed.

Permit Fees

The Filing and Technology Fees are applied to each permit type. Plan Check Fees and Inspection Fees are project specific and vary for each permit.

Initial plan check fees cover the first hour of plan review. For plan review time over one hour, additional fees will be added.

Minimum inspection fees will be assessed prior to permit issuance. For projects requiring additional inspections, additional inspection fees will be added after permit issuance.

- a The filing fee and technology fee are one-time fees assessed per permit. All other fees are minimum hourly or base fees.
- b Fire inspection fees are billed at a rate of (\$125 per 15 mins). Additional Fire inspection time will be assessed at the discretion of the fire inspector. (FF330)
 - Additional/Overtime Inspection (FF1430) - 2 hr minimum \$500 x 2 = \$1000
 - After-Hours/Call Back Inspection (FF1440) - 4 hr minimum \$500 x 4 = \$2000
 - Additional plan check and inspection fees may apply for plan review that exceeds the first hour base fee.
- c A separate Toxics permit is required for storage tank installation and/or removal. Contact the Toxics Management Division for permit application information, at toxics@berkeleyca.gov or (510) 981-7460.
- d This form is not a complete list of construction and operational fire permits.
