Item Description: Excused Absence for Councilmember Hahn

This item is submitted pursuant to the provision checked below:

- Emergency Situation (54954.2(b)(1) - majority vote required)
Determination by a majority vote of the legislative body that an emergency situation exists, as defined in Section 54956.5.
- Immediate Action Required (54954.2(b)(2) - two-thirds vote required)

RECOMMENDATION

Excuse Councilmember Sophie Hahn from the October 29, 2024 Council meeting due to illness.

BACKGROUND

Pursuant to the City Charter, Article V, § 19, the City Council must approve an absence by the Mayor or a Councilmember from a meeting in order for that absence to be considered excused. Specifically, it states:

If the Mayor or any member of the Council is absent from one or more regular meetings of the Council during any calendar month, unless excused by the Council in order to attend to official business of the City, or unless excused by the Council as a result of their own illness or the illness or death of a “close family member” as defined in the City’s bereavement policy from attending no more than two regular meetings in any calendar year, they shall be paid for each regular meeting attended during such months in an amount equal to the monthly remuneration divided by the number of regular meetings held during such month.

Councilmember Hahn was unable to attend the October 29, 2024 Council meeting due to illness.
