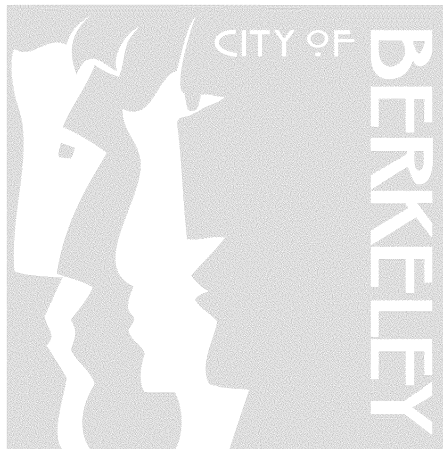

CALIFORNIA RETAIL FOOD INFORMATION

Operating without a valid health permit is a violation of Health and Safety Code - California Retail Food Code (CRFC), Chapter 13 on Compliance and Enforcement.

The following sections of the code are applicable to your food facility:

- A food facility shall not open without a valid health permit [CRFC Section 114381(a)]
- Any person who operates a food facility shall obtain all necessary permits to conduct business, including, but not limited to a permit issued by the enforcement agency [CRFC Section 114387]
- Any person who violates any provision of this part or regulation is guilty of a misdemeanor. Each offense shall be punished by a fine of not less than twenty-five dollars (\$25) or more than one thousand dollars (\$1,000) or by imprisonment in the county jail for a term not exceeding six months, or by both fine and imprisonment [CRFC Section 114395].
