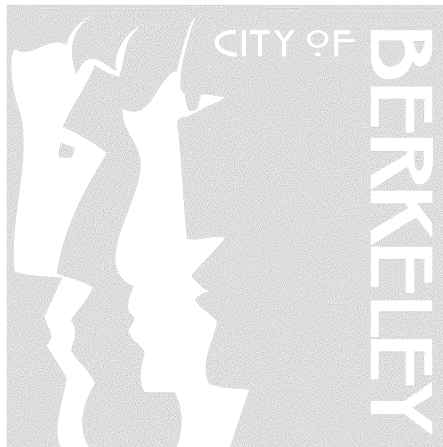

## BILLING TERMS

The entire bill is due and payable by the date stated on the face of the bill. If the bill is not paid by the due date, a 10% late charge will be assessed.

You may pay by cash, check, or credit card (Visa or Mastercard) at our Customer Service Center located at 1947 Center Street, 1<sup>st</sup> Floor, Monday - Thursday, 8:30AM to 4:00PM. Or, you may pay online at [berkeleyca.gov/city-services/report-pay](http://berkeleyca.gov/city-services/report-pay) or by phone (510) 981-7270 with Visa or Mastercard.

There is a \$20.00 return check charge on all returned checks and declined credit card transactions.

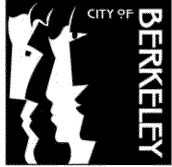

When making a written inquiry, please include your name, service address, account number, and a description of the issue. You do not have to pay amounts in question while we investigate. However, you are responsible for paying the amount not in question.

## CURBSIDE SERVICE

All carts must be placed in the street with wheels up against the curb with 1 foot of space in between carts and 3 feet from vehicles and other obstacles with lids closed completely by 7:00AM on your service day. Please remove carts from the curb within 24 hours of collection.

Holidays resulting in collection interruption are Thanksgiving, Christmas, and New Year's Day. During those weeks, if your collection day falls on or after the holiday, your carts will be picked up one day late.
