# Land Acknowledgement Statement

The City of Berkeley recognizes that the community we live in was built on the territory of xučyun (Huchiun (Hooch-yoon)), the ancestral and unceded land of the Chochenyo (Cho-chen-yo)-speaking Ohlone (Oh-low-nee) people, the ancestors and descendants of the sovereign Verona Band of Alameda County. This land was and continues to be of great importance to all of the Ohlone Tribes and descendants of the Verona Band. As we begin our meeting tonight, we acknowledge and honor the original inhabitants of Berkeley, the documented 5,000-year history of a vibrant community at the West Berkeley Shellmound, and the Ohlone people who continue to reside in the East Bay. We recognize that Berkeley's residents have and continue to benefit from the use and occupation of this unceded stolen land since the City of Berkeley, it is not only vital that we recognize the history of this land, but also recognize that the Ohlone people are present members of Berkeley and other East Bay communities today.

### RECOMMENDATION

Refer to the City Manager and the Community Health Commission an assessment of the breadth of regulatory control the City of Berkeley can exert on skilled nursing facilities, and create a process of accountability if complaints are found to be substantiated that threaten, or could potentially escalate to the point of threatening, the wellbeing of patients and/or violate federal, state, or local law; the business license of the offending facility will be suspended until the skilled nursing facility submits a report demonstrating rectification of the situation.

### BACKGROUND

The California Department of Public Health (CDPH) mandates that skilled nursing facilities provide 3.5 hours of patient care to each patient per day.<sup>1</sup> For instance, some care facilities in Berkeley are reported to have as few as 6 staffers serving 66 patients, meaning that even if the staff worked around the clock, at most they would be able to offer 2.1 staff hours per patient per day. In 2021 alone, the facility has received 12 complaints, but not a single one has been followed up by an enforcement action<sup>2</sup>. This is just a single example in an egregious pattern of lack of care met with lack of enforcement. In 2019, for example, skilled nursing facilities were found to violate an average of 23 federal and state laws per facility. Yet, in the 77 skilled nursing facilities across California, not a single regulation was enforced. As a result, there has been a history of negligence, mistreatment, and patient abuse within Californian care facilities.<sup>3</sup>

### **CURRENT SITUATION**

The City has received numerous grievances from concerned community members over the quality of care in certain skilled nursing facilities in Berkeley. Community members complain of neglect, indifference, and harmful, negligent behavior with sometimes tragic consequences.

The City must address these hazards by creating internal procedures and policies designed to prevent further harmful acts. Precedence for license revocation policies can be found in other municipalities. For example, Chapter 6 Section 1.80 of Superior, Colorado Municipal Code states that business licenses can be suspended "when any activity conducted by the licensee, his or her employee or agent violates any federal, state or local rule, regulation or law.<sup>4</sup> The City

of Berkeley could adopt such an ordinance to shutter inept care facilities and deter improper conduct and mismanagement.

Furthermore, to ensure enforcement, the City could mandate that all complaints be forwarded to the Environmental Health Division to be reviewed in a timely manner. This would prevent a backlog of complaints and strengthen City follow-through.

The City of Berkeley needs to enforce strict regulations over the performance and conditions of skilled nursing care facilities to ensure that patients are not stripped of their right to quality care. As stated above, a particularly skilled nursing care facility received 12 complaints in 2021, but there was zero enforcement action taken against them. With this recommendation, there will be a strict standard that skilled nursing care facilities must meet to guarantee that issues are adequately addressed by the City of Berkeley. Furthermore, it provides safeguards to ensure that patients are not neglected by those assigned to look after them.

### FINANCIAL IMPLICATIONS

Determine as part of City Manager and Commission response.

Suppose the City can regulate skilled nursing facilities (generally not a City role). In that case, there could be significant financial implications because there is currently no staff assigned to this work in the City.

Dear Commissioners,

I am a disabled senior. In my neighborhood the skateboards, scooters, bicycles, and unicycles we routinely try to dodge to navigate simple errands became untenable years ago. The fact that the extant laws are unenforced - but not unenforceable - does not mean that they don't matter. Unless you think, as Councilmember Robinson appears to do, that the lives and safety of disabled seniors and vulnerable pedestrians are unimportant. Unless you think, as Councilmember Robinson seems to do, that the ADA is unimportant.

This may not currently be on your agenda. Please put it on. Take a strong, early stand against this thoughtless, dangerous, unconstitutional proposal.


I am from the generation that fought and secured the federal protections of the Americans with Disabilities Act, which would be controverted by Robinson's proposal. I also fought hard, as a life-long bicycle commuter through the direct action of Critical Mass rides, for the recognition of bicycles as **vehicles,** vehicles with every right to the roadway, a recognition which has changed roadways widely in favor of bicycle safety. If safe roadways for the vehicles **that bicycles in fact are** under the law are not enough for bicyclists, by all means they should fight as hard as we did for dedicated bike lanes.

But Berkeley needs to fight much harder for its vulnerable seniors, whose voices are not covered as robustly as the nationwide bike lobby, which not only dominated honest discussion of the safety issues at Gilman and Monterey, they cost us another valuable department director literally unable to navigate the political pressure to accomplish contradictory directives.

Stand up for safety. Stand up for seniors. Stand up for the disabled and physically vulnerable of any age. Stand up for sidewalks as dedicated, safe, pedestrian walkways. Take advantage of this moment to recommend that this proposal not only be flatly rejected, but that signage and enforcement to protect sidewalks as safe spaces to walk be improved so that the legal rights we currently have are, in fact, manifest in our daily efforts to safely get to the market, the post office, the bank, etc. Bicycles, under the law, are vehicles, are capable of being lethal in the best of hands, and do not belong on sidewalks.

Councilmember Robinson, representing District 7, has resigned from the Berkeley City Council, effective 5:00 p.m. on January 12, 2024. This memo addresses certain matters concerning the roles and responsibilities of the commissioners serving under his appointment. Please share this information with your commission.

### 1. Leaves of Absence

Municipal Code Section 3.02.030 states that "a member of a board, commission or committee may be granted a leave of absence not to exceed three months by the appointing Councilmember or the Council..." It goes on to say that "the appointing Councilmember or the Council may fill such a vacancy by a temporary appointment..."

Since the Council as a whole may only grant leaves of absence to commissioners that the council appoints as a whole, there is no provision for the appointees of a vacant council seat to obtain a leave of absence. Please advise your District 7 appointees that any absence from commission meetings will be considered an unexcused absence and will be reported on the next semi-annual attendance report.

# 2. Appointments/Re-appointments

No new appointments/re-appointments may be made for District 7 vacancies until a new Councilmember has been elected to this office.

### 3. Temporary Appointments

No temporary appointment may be made for a District 7 commission seat until a new Councilmember has been elected to this office.

### 4. Terms of Office

Berkeley Municipal Code Section 2.04.075 provides that a commissioner's *term* expires upon the resignation of the councilmember who appointed them. In this context, "term" refers to the initial term of the commissioner which normally expires on December 1 of the first year of their appointment. The commissioner's *service* on the commission is extended beyond the resignation of the Councilmember and they may continue to serve as a "hold over" commissioner until a new appointment is made. Of course, these commissioners are still subject to all the requirements for commission membership and service (e.g. Form 700, attendance, etc.).
