

Subject: Deconstruction Ordinance Update 05-22-19

Dear Deconstruction Stakeholder,

The City developed a proposed ordinance for deconstruction and construction materials management (Deconstruction Ordinance) that incorporates key initiatives from the 2018 Zero Waste Plan, and that when fully implemented moves the City closer to achieving Palo Alto's



Sustainability/Climate Action Plan goal of 95% waste diversion from landfills by 2030.

Over 40% of the waste from Palo Alto that is disposed in landfills is from construction and demolition related projects (see chart).

We previously sent you the draft concepts for the Deconstruction Ordinance and some of you joined us in 2018 in meetings to discuss the concepts and provide feedback. The concepts shared involved a broader scope, not limited to whole building demolition projects as now proposed, and applied to most construction and remodel projects. As a result of your feedback, staff modified the draft concepts, identified three phases for implementation, and is now proposing Phase 1 as a new ordinance. City staff anticipates in the future recommending extending the ordinance in two later phases, which are included in the attached Deconstruction Ordinance summary. The Deconstruction Ordinance summary shows three phases, but only the first of which will be included in the June 10 ordinance proposal.

This email is to advise you that the proposed Deconstruction Ordinance will be going through Council review at the regular June 10 Council meeting. The new deconstruction ordinance would require residential and commercial projects undergoing complete building demolition to deconstruct (not demolish) structures. These projects would 1) complete a salvage survey to be conducted by a City approved reuse organization listing the materials and items from the

building that can be salvaged for reuse, 2) upon completion of the deconstruction, report back to the City on the quantity of materials and items accepted for reuse, 3) source separate materials that can be recycled and composted and deliver to City approved material recovery facilities, and 4) use GreenWaste of Palo Alto, the City's contracted hauler, for all containers (bins or debris boxes) used at the deconstruction sites.

A link to the exact ordinance language and Staff Report will be sent to you on or about May 30, when it becomes public.

# Deconstruction & Construction Materials Management Summary (Deconstruction Ordinance – Chapter 5.24)

Phases	Deconstruction Phases Summary	Number of Estimated Projects
Phase 1 - effective July 2020	Salvage survey, reuse and source separation on residential and commercial projects required to obtain permits for complete demolition	114
Phase 2 - effective ~January 2022	Salvage survey, reuse and source separation on all projects valued at \$100,000 or more	334
Phase 3 - effective ~January 2023	Lower threshold to \$50,000 or more	138

#### 1) SALVAGE SURVEY AND REUSE

<u>Currently</u> - Only residential whole house demolition permits are required to complete a salvage survey. Permittees are not required to salvage materials on the survey.

**<u>NEW:</u>** Salvage surveys will be required on all projects within each phase; survey and certification on materials and items accepted to be conducted by City approved reuse organizations.

#### 2) DECONSTRUCTION AND SOURCE SEPARATION

<u>Currently</u> – Demolition is allowed, and construction related waste can be mixed. All projects that are \$25,000 or more in value are required to submit a debris management plan to the City and contractors must input weights into Green Halo to track the project tonnage with a goal of achieving 80% diversion for each project.

**<u>NEW:</u>** Deconstruction and source separation will be required on all projects within each phase. Materials must be source separated and delivered to City approved materials recovery facilities.

#### 3) GREENWASTE AS THE APPROVED COLLECTOR

<u>Currently</u> - Contractors are allowed to use any waste hauler for collection of source separated material in debris boxes.

**<u>NEW:</u>** Contractors will utilize GreenWaste to haul all materials if using containers (bins or debris boxes) at project sites. Contractors can continue to self-haul material by using trucks but must still source separate materials in accordance with City requirements and deliver materials to City approved processing facilities.
