Report-Back from the Covid-Related Waste Mitigation Subcommittee

Grocers and restaurants are still relying heavily upon single use items, or encouraging them as a result of covid policies (e.g., requiring bagging outside if in own bags, encouraging take out). Sub-committee suggests City needs to consider what guidance to provide regarding compliance with local ordinances to reduce such reliance as we emerge from Covid restrictions. The Zero Waste Commission should discuss how to best address this and whether prior discussion with City or County public health officials is advisable.

- "no credible evidence of food or food packaging associated with or as a likely source of viral transmission of ... SARS-CoV-2"
- It's a respiratory illness that spreads person to person, not a foodborne illness
- Chances of infection by eating food or touching food packaging are very low because the number
 of virus particles that could be picked up is very small and the "amount needed for infection via
 oral inhalation would be very high"
- Out of all covid cases, there has been no evidence of food/food packaging as the source of transmission

Alameda County has this posted re reusable bags:

Many studies and health experts have provided documentation regarding the safety of reusable bags and foodware items relating to COVID-19 concerns. Over 115 health experts from 18 countries, including virologists, epidemiologists, emergency room doctors, and specialists in public health and food packaging safety, signed onto a statement addressing the safety of reusable bags and containers during the COVID-19 pandemic. 
