LAND ACKNOWLEDGEMENT

The City of Berkeley recognizes that the community we live in was built on the territory of xučyun (Huchiun (Hooch-yoon)), the ancestral and unceded land of the Chochenyo (Cho-chen-yo)-speaking Ohlone (Oh-low-nee) people, the ancestors and descendants of the sovereign Verona Band of Alameda County. This land was and continues to be of great importance to all of the Ohlone Tribes and descendants of the Verona Band. As we begin our meeting tonight, we acknowledge and honor the original inhabitants of Berkeley, the documented 5,000-year history of a vibrant community at the West Berkeley Shellmound, and the Ohlone people who continue to reside in the East Bay. We recognize that Berkeley's residents have and continue to benefit from the use and occupation of this unceded stolen land since the City of Berkeley's incorporation in 1878. As stewards of the laws regulating the City of Berkeley, it is not only vital that we recognize the history of this land, but also recognize that the Ohlone people are present members of Berkeley and other East Bay communities today. The City of Berkeley will continue to build relationships with the Lisjan Tribe and to create meaningful actions that uphold the intention of this land acknowledgement.

Proposed Local Amendments to 2022 CAL Green Code with Mid-Cycle Supplements

CA Building Code Adoption Process





Triennial Code Adoption Cycle

- New editions of the California Building Standards Code are published every three years in a triennial cycle with supplemental revisions to the code published at 18 months (Mid-Cycle)
- State law requires local governments to enforce the latest edition of the California Building Standards Code
- 2022 California Building Standards Code with Berkeley's local amendments went into effect on **January 1, 2023**
- California 2024 Mid-Cycle Supplements effective July 1, 2024 will require Berkeley amendments to be adopted

Proposed Mid-Cycle Code CALGreen Amendments







- Increased multifamily EV charging
 - parking lifts
- Increased Construction and Demolition (C&D) waste diversion (retain)
- Low-carbon concrete (retain)
- Zero NO_X

NOTE: CALGreen also has new requirements for the deconstruction and reuse of existing non-residential structures

New: CALGreen Deconstruction and Reuse



Previously adopted amendment: C&D Waste

Construction and Demolition (C&D) Waste Management

- Diversion of at least 65% of nonhazardous C&D waste by recycling, reuse, and salvage
- 100% diversion of asphalt, concrete, and land-clearing debris (excavated trees, stumps, rocks, etc.)

Previously adopted amendment: Concrete


Low-Carbon Concrete


- Reduce cement in concrete mix design by at least 25%
 - Cement alternatives include fly ash, slag, silica fume, rice hull ash, etc.

Cement used in concrete is the single largest material source of embodied emissions in buildings, responsible for 8% of global emissions



New Mid-Cycle amendment proposal: Zero NOx





Newly constructed buildings must be Zero NOx Emission Buildings

- A Zero NOx Building uses no NOx Emitting Equipment/Appliances for space heating, space ventilation, water heating, cooking, clothes drying and/or lighting
 - Includes future additions and alterations
- Applies to all newly constructed buildings (residential and non-residential) except for industrial/heavy manufacturing processes

AIR POLLUTANT IMPACTS:


















Zero NOx Background

- Supports Berkeley's Strategic Plan, Climate Action Plan, and Fossil Fuel Free City goals
 - Limits the human health, environmental, and climate impacts of emissions associated with building occupancy
- Supports Bay Area Air Quality Management District (BAAQMD) Zero NOx Appliance requirements that begin in Jan 2027
- Builds on Los Altos Hill's Zero NOx ordinance adopted earlier this year
