#### 3. LAND ACKNOWLEDGEMENT

The City of Berkeley recognizes that the community we live in was built on the territory of xučyun (Huchiun (Hooch-yoon)), the ancestral and unceded land of the Chochenyo (Chochen-yo)-speaking Ohlone (Oh-low-nee) people, the ancestors and descendants of the sovereign Verona Band of Alameda County. This land was and continues to be of great importance to all of the Ohlone Tribes and descendants of the Verona Band. As we begin our meeting tonight, we acknowledge and honor the original inhabitants of Berkeley, the documented 5,000-year history of a vibrant community at the West Berkeley Shellmound, and the Ohlone people who continue to reside in the East Bay. We recognize that Berkeley's residents have and continue to benefit from the use and occupation of this unceded stolen land since the City of Berkeley's incorporation in 1878. As stewards of the laws regulating the City of Berkeley, it is not only vital that we recognize the history of this land, but also recognize that the Ohlone people are present members of Berkeley and other East Bay communities today. The City of Berkeley will continue to build relationships with the Lisjan Tribe and to create meaningful actions that uphold the intention of this land acknowledgement.

Subject: FY24 Grant Cycle and Awards

This memo outlines the processes used and accomplishments achieved during the Fiscal Year 2024 grant cycle.

#### 1. Guidelines Development

The Grants Subcommittee discussed the FY24 grant guidelines for the Individual Artist Projects, Community Festivals, and General Operating Support grants over six meetings. Feedback received from applicants and panelists from the FY23 grant cycle were incorporated in the guidelines. Staff observations of areas for improvement from the FY23 grant cycle were also incorporated. Some of the policy change considerations during the Grants Subcommittee meetings included:

- Updated review criteria and criteria percentages
- Inclusion of a more defined scoring rubric
- Clearer eligibility and project requirements
- Addition of grant request amounts
- Removal of tiered award amounts based on organizational or event budget size

#### 2. Panelist Recruitment

On August 10, 2022, a call for panelists was released to recruit grant review panelists from around the Bay Area. The call was advertised through the Civic Arts newsletter, social media, and direct contact with individuals. The call for panelists closed on November 10, 2022. This recruitment process more than doubled the panelist pool from 20 people in the last panelist pool to 42 for the FY24 pool.

#### 3. Grant Opportunity Outreach and Promotion

Several strategies for promoting our FY24 funding opportunities were used. Grants were advertised in the Civic Arts newsletter, social media, and to previous grant applicants. Staff gave a grants program presentation at the February 8, 2023 Berkeley Cultural Trust meeting, and the City's communications team advertised the applications through their Community Message channel and Twitter account.

### 4. Application Period and Technical Assistance

The three core grant programs all opened on January 9, 2023. The deadlines for each grant category were staggered to give larger application periods to the organizational grants.

A Technical Assistance workshop was given by staff for each grant category during the application period. Potential applicants could attend these workshops live or view the recordings on our website. The workshops were advertised in the Civic Arts Newsletter, as events on the City of Berkeley website, and through social media.

Throughout the application period, applicants could get help with their applications from staff by email, virtual appointment, or phone. Approximately 465 emails were exchanged for technical assistance, 24 virtual appointments were scheduled, and fewer than 10 phone calls were received by applicants seeking assistance.

Civic Arts received a similar amount of applications as in the FY2023 grant cycle for Festivals and Individual Artists. Though a similar amount of applications were received, many first-time applicants were included in the application pool. Some previous applicants to our grant programs either closed their organizations, were no longer eligible with clearer eligibility requirements, or chose not to apply this year.

After submitting an application, applicants were emailed a Grant Application Survey to give feedback about their panel service. A total of 148 Grant Application Surveys were received. Data collected in this survey will be used to improve future grant review processes.

#### 5. Panelist Training and Resources

Panelists were selected from the approved panelist pool based on experience relevant to our grant categories and expertise with the artistic disciplines present in the applicant pool. In adhering to our values of equity, Black, Indigenous, and People of Color were also prioritized to serve as panelists.

Panelists were given several resources to help them with their evaluations and prepare them for the grant review panel meeting.

 Panelist Handbook: Staff created a panelist handbook for panelists to reference throughout their review period. The handbook includes definitions of conflicts of interest, using Submittable, tips for creating constructive panelist notes, and other information pertinent to panel service.

- Panelist Orientation and Training: All panelists attended an orientation webinar
  to go over the full grant review process. Each grant category had its own panelist
  webinar to give evaluation guidance in the context of the specific grant program.
  This training is performed to help orient panelists with the review criteria and
  prepare them for a productive grant review panel discussion.
- Technical assistance was available to panelists via email, phone, and virtual appointment throughout the review period.

## 6. Review Panel Meetings

Four distinct grant review panel meetings were held to evaluate all 150 eligible applications.

With 65 eligible General Operating Support applications received, this grant category was split into two panels. GOS1 included applications from organizations with total revenues of over \$300,000, and GOS2 included applications from organizations with total revenues of under \$300,000.

During the review period, one GOS1 applicant organization permanently closed, so a total of 30 applications were reviewed in that panel instead of the original 31.

All panels included three grant review panelists who attended the required panelist orientation. However, one panelist serving on the Community Festivals panel did not complete their reviews, resulting in that grant category being evaluated by two panelists.

Several applicants attended the public grant review panels, and used their opportunity to address the panel for clarification. Many present applicants expressed gratitude for the panelist comments and for the opportunity to attend the open process.

After each panel concluded, panelists were emailed a Panelist Experience Survey to give feedback about their panel service. Data collected in this survey will be used to improve future grant review processes.

#### 7. Awards and Recommendations

Once panels concluded, staff created funding scenarios for each grant category given the number of applicants, anticipated allocations from the city's General Fund, and scores.

The funding scenarios were reviewed and voted on by the Grants Subcommittee at their June 5, 2023 meeting.

#### **Individual Artist Projects**

One funding scenario was presented in this grant category. The scenario included funding 11 applicants \$4,000, totaling \$44,000 from the anticipated \$500,000 Civic Arts Grants allocation. Though originally planning to award 10 applicants, the top 11 scoring applicants were very close in score, with the next three applicants tied in the same score. The 11 top scoring applicants represent a diversity in demographics, discipline, and Council Districts.

The Grants Subcommittee voted to recommend this funding scenario to the Civic Arts Commission.

#### **Community Festivals**

Two funding scenarios were presented in this grant category. Scenario 1 reflects a Festivals Grant allocation of \$200,000, which is the allocation received in FY2023. Scenario 2 reflects a Festival allocation of \$158,315, which was the amount allocated for this grant category in FY2020. With the exact allocation unknown at this time, the two scenarios account for both allocation possibilities.

The award amounts are tiered by percentage of grant request amounts; the percentages change in places where there are large differences in scores.

Scenario 1 percentages: 100, 95, 90, 82.5 Scenario 2 percentages: 100, 87.5, 76.72

Total awards: 31 Total awards: 26

The Grants Subcommittee voted to recommend both funding scenarios to the Civic Arts Commission.

#### **General Operating Support**

Three different funding scenarios were presented in this grant category.

Scenario 1 includes tiered award amounts based on the percentage of request amounts. The percentages change based on places were there are large jumps in scores and excludes the lowest scoring applications from funding. This methodology was applied to both GOS1 and GOS2 and with funding distributed proportionately given the amount of applications in each panel.

Scenario 1 award percentages: 100, 90, 80, 70

The Grants Subcommittee voted to recommend Scenario 1 to the Civic Arts Commission.
