

Land Acknowledgement Statement

The City of Berkeley recognizes that the community we live in was built on the territory

of xučyun (Huchiun (Hooch-yoon)), the ancestral and unceded land of the Chochenyo

(Cho-chen-yo)-speaking Ohlone (Oh-low-nee) people, the ancestors and descendants

of the sovereign Verona Band of Alameda County. This land was and continues to be of

great importance to all of the Ohlone Tribes and descendants of the Verona Band. As

we begin our meeting tonight, we acknowledge and honor the original inhabitants of

Berkeley, the documented 5,000-year history of a vibrant community at the West Berkeley Shellmound, and the Ohlone people who continue to reside in the East Bay.

We recognize that Berkeley's residents have and continue to benefit from the use and

occupation of this unceded stolen land since the City of Berkeley's incorporation in

1878. As stewards of the laws regulating the City of Berkeley, it is not only vital that we

recognize the history of this land, but also recognize that the Ohlone people are present

members of Berkeley and other East Bay communities today. The City of Berkeley will

continue to build relationships with the Lisjan Tribe and to create meaningful actions

that uphold the intention of this land acknowledgement.

To The Berkeley Unified School District Board of Education:

It has come to the attention of the Peace and Justice Commission that many 9th grade students at Berkeley High were recently taught a set of lessons about the Israel Hamas War that included factually incorrect information. Of note, this curriculum includes an inaccurate definition of the Holocaust. It also includes a description of Gaza from 20 years prior that erroneously stated that thousands of settlers still live in Gaza. We are concerned to learn about this development.

Both the School Board and the Peace and Justice Commission are tasked with advancing a peaceful and democratic society. For Berkeley to remain a place where fervent discourse, critical thinking, and engaged citizens continue to press for a more just society, the next generation must have universal access to accurate information and be taught the skills needed to engage in this effort. We write to encourage the School Board to review the history curriculum, in particular this newly developed lesson set, for historical accuracy and reputable sources. We urge you to quickly correct factual inaccuracies in the curriculum. Thank you for your time and attention to this matter.

This year's readings are again part of the Poor People's Campaign initiative to build support for the Third Reconstruction Agenda to Heal the Nation: End Poverty and Low Wages From the Bottom Up.

An updated "tool kit" for the 2024 readings has been posted by PPC National Mobilizing Partner, United for Peace & Justice, at Organize a Public Reading of Dr. King's "Beyond Vietnam" Speech in your Community - United For Peace and Justice. In the tool kit, you'll find the text of the speech, divided into 16 sections, in English. You'll also find an updated introduction for 2024 that connects the speech to the ongoing Russian war in Ukraine and the Israel-Hamas war.

Background:

On April 4, 1967, exactly one year before his tragic assassination, in his prophetic speech, "Beyond Vietnam: A Time to Break Silence," Dr. Martin Luther King, Jr. declared: "I am convinced that if we are to get on the right side of the world revolution, we as a nation must undergo a radical revolution of values.... we must rapidly begin the shift from a thing-oriented society to a person-oriented society. When machines and computers, profit motives and property rights, are considered more important than people, the giant triplets of racism, extreme materialism, and militarism are incapable of being conquered."

The Poor People's Campaign: A National Call for Moral Revival has picked up Dr. King's unfinished work weaving the interlocking injustices of systemic racism, systemic

poverty, environmental devastation, militarism and the war economy and a distorted moral narrative of Christian nationalism that blames poor people for their own poverty, into one "moral fusion" campaign.
