- Wildfire Prevention / Mitigation Vegetation Management Inspections –
 - No New Updates
- Retired Annuitants The retired annuitants are largely focused on performing vegetation inspections for properties in fire zone 2 and 3.
 They are also looking at transitioning the inspection from paper to mobile technology, re-tooling the re-inspection, citation, and violation process. The Department has also expanded its traditional hazardous fire area program to include all properties in fire zones 2 and 3.

- Dispatch Study: Our goal, per Council direction is to enhance the dispatch center so it can triage calls, divert non-emergency calls (including mental health calls) to appropriate resources like the SCU; and provide emergency medical instructions to callers.

- Division of Training Property The Department is actively engaged to
 find a piece of property that will meet the City's needs for the training

 zoning, the cost of property and the proximity of residential units to
 most property in Berkeley, this location will likely be outside the City
 proper. This presents exciting opportunities for regional collaboration
 with other fire departments and a community college district.

 - Outdoor Warning System The first phase of the Outdoor Warning System has been completed. Berkeley Fire is facilitating the vendor's ongoing progression with the permitting process through the State Department of Architecture.

- a. City Council appointed Dave Sprague to the position of Fire Chief.
- b. 70 y/o Cardiac Arrest which was witnessed by the patients partner and bystander CPR was initiated. With quick work by Engine 7 and then continued care by our medics resulted in Return Of Spontaneous Circulation (ROSC) during transport.
- c. The last weekend in April, we re-booted the First-In camp and it was awesome. It was a great turnout and all made possible by our field personnel and a few retired personnel coming back to help out.
- d. The first three weeks into the new city-wide chipper program yielded over 100 pickups, picking up 153 cubic yards of vegetation and are maintaining a 5.0 (highest possible) rating with 45% of customers responding to the post appointment survey. 5. Emergency Preparedness

- a. Free, in-person Community Emergency Response Team (CERT) courses for community members who live or work in Berkeley restarted in May. An initial offering of courses is available on the CERT Program webpage, and additional classes are being announced as they are scheduled. The Berkeley Fire Department has also restarted a bi-monthly disaster preparedness meet-up for community members on the second Wednesday of the month at the Division of Training. The next meet-up is scheduled for July 12.
- b. In the last month, the Office of Emergency Services delivered emergency preparedness presentations for community members at Ashby Court Apartments and University Neighborhood Apartments.

6. Grants

A lot of work is going into this and the benefits will be a huge win for the City.

May 24, 2023: Disaster and Fire Safety Commission, Item for Action: From: Commissioner Shirley Dean

I move that the Disaster and Fire Safety Commission consider the problem of firefighter vacancies as it applies to high rise buildings and approve the following motion:

The Disaster and Fire Safety Commission (DFSC) recognizes that the Fire Department currently has long-standing firefighter position vacancies, and that while the Department has worked for many years to resolve this problem, the problem remains in spite of these active efforts. Further, the DFSC predicts the problem will increase as the City enters a time of construction of more and more high rise buildings. In view of this, the DFSC recommends that for the well-being of renters and visitors in high rise buildings and for the firefighters that must protect them, the Council consider establishing a height-related Fire Fighting Surcharge, which will be applied to all buildings requiring the services of additional firefighters and that the proceeds of such surcharge will be used solely for the recruitment, training and retention of Firefighter personnel and for any special equipment that they might need.

Background:

During a Council Budget Committee meeting on April 27, 2023, Committee Members heard Fire Chief David Sprague give a presentation on the shortage of firefighters, the use of voluntary and mandatory overtime and the steps being taken to recruit, train and retain fire fighters. At that meeting, Chief Sprague stated that the Department has been working on the problem of vacant positions for the last couple of decades, but that zoning and development has changed and Berkeley is transitioning into an urban metro community. He stated that while we're only ten square miles, we're the second densest in the top fifty-one most populated cities in California.

Berkeley's ladder trucks currently reach to only 8 stories. (There are some new types of ladder trucks that are coming from Europe that have much higher ladder reach, but they're not generally available in the United States yet.) But, when the Department responds to anything above five floors, it's about sending a significant number of personnel to those calls. It's a report about smoke, so responders don't use the elevator. They transport equipment upstairs while at the same time people are evacuating. Each responder carries about 50 to 75 pounds of equipment. By the time they get to the actual incident floor, they are already pretty tied and have to use breathing air, so those tanks have to be carried as well. The tanks last for about 10 to 15 minutes of work. So, essentially you have to have about 50 to 100 firefighters for the kind of standard fire that could be handled with about 30 on the ground floor in a residential unit. If the fire is anything more significant than a couple of rooms in an elevated building, you will be looking at several 100 fire fighters, a number that's been proven by departments that fight fires in places like San Francisco or New York. It's really about personnel. And while such fires are low frequency, they are high in risk.

Alternatives:

There are three alternatives to consider as follows:

- 1. Continue what is currently being done. This approach requires continuing the considerable work that detracts from working on other programs. However, experience over time has proven this approach does not really produce results. Furthermore, a March 20, 2023 article written by John King, architecture critic, published on the front page of the San Francisco Chronicle, titled Housing Towers are Coming to Downtown Berkeley whether the City wants them or not confirms that at least six major buildings, by address in the Downtown, are under consideration for construction. These buildings range in height from 28 stories to 15 stories. One of the buildings, 2190 Shattuck, 25 stories, 260 feet tall, was approved by the Zoning Adjustments Board just a few days ago. From what we have learned from the Fire Chief, fires in these tall buildings are few, but high risk in terms of the physical and mental health of both the residents and the firefighters. Knowing this, there is a predictable likelihood that knowing the problem, fewer new hires would choose working here and the number of firefighter vacancies would increase as the number of high rise buildings increase, placing future efforts at even higher risk.
- 2. <u>Seek approval for a citywide tax increase to hire additional firefighters.</u> Such a measure may well face difficulty obtaining citywide approval given that the developer's anticipated profit is untouched, and there well might be additional tax measures presented to the electorate.
