Dear Honorable School Board,

We are writing in our capacity as the City of Berkeley Youth Commission to urge you to fund two gender-neutral bathrooms at Willard Middle School. One would be in the main academic building, Tudisco Hall, and the other would be in the gym building.

Willard needs gender neutral bathrooms because, as one student said, "some students at this school are Transgender and Non-Binary/Genderqueer and they might not feel comfortable using a certain gender bathroom." Another student said that a Transgender girl/boy who just came out might not want to use a gender specific bathroom yet, so they would feel more comfortable using a gender neutral bathroom. Furthermore, a Non-Binary student might not want to use a gender specific bathroor, a Non-Binary student might not want to use a gender specific bathroor.

By working closely with the Willard Gender and Sexuality Alliance (GASA), we have learned that next to the main and smaller gyms there are two designated boys' and girls' bathrooms. These are infrequently used because there are already bathrooms in the gym for girls and boys. The main and small gym bathrooms could easily be turned into a gender neutral changing room and bathroom. The stalls can stay for students who need to change out of something they are binding their chest with, as it is unsafe to exercise while binding. And the other bathroom could be a gender neutral bathroom. The only change needed would be extra lockers and new signage, which is not extremely expensive.

For Tudisco Hall, it would be great to have at least one gender neutral bathroom in the multi-floor building. Right now on each floor, there is only one girls' and boys' bathrooms. It would be ideal to convert the bottom floor bathrooms into two gender neutral bathrooms. Or, to convert one of the two staff bathrooms into a gender neutral bathroom for everybody.

This is a problem throughout Berkeley middle schools, and students are aware and insisting change. The President of the GASA said, "Gender neutral bathrooms are crucial not only because they provide a place for students to use the bathroom, [but] they help push Willard forward as a welcoming and supportive school. It's a hard switch but a very important one."
