Dear Honorable School Board,

We are writing in our capacity as the City of Berkeley Youth Commission to urge you to fund gender-neutral bathrooms at Willard Middle School.

Willard needs gender neutral bathrooms because, as one student said, "some students at this school are Transgender and Non-Binary/Genderqueer and they might not feel comfortable using a certain gender bathroom." Another student said that a Transgender girl/boy who just came out might not want to use a gender specific bathroom yet, so they would feel more comfortable using a gender neutral bathroom. Furthermore, a Non-Binary student might not want to use a gender-specific bathroom because they do not apply to either binary gender. It is evident that Willard students are aware of the lack of inclusivity in bathrooms and want change.

By working closely with the Willard Gender and Sexuality Alliance (GSA), we learned that there are specific locations where a gender neutral bathroom could be built or an existing bathroom can be converted. Some of these existing bathrooms are infrequently used and could easily be turned into a gender neutral changing room and bathroom. This is important because the stalls can be used for students who need to change out of something they are binding their chest with, as it is unsafe to exercise while binding. And the bathroom would be a gender neutral bathroom.

This is a problem throughout Berkeley middle schools, and students are aware and insisting on change. The President of the GSA said, "Gender neutral bathrooms are crucial not only because they provide a place for students to use the bathroom, [but] they help push Willard forward as a welcoming and supportive school. It's a hard switch but a very important one."
