# **Staff Updates**

- 1. Staff informed Commissioners that Vice-Chair Walsh was on a leave of absence through 12/13/23 and that this would not impact the Commission's current quorum.
- 2. Regarding the Log of Access Complaints, there was consensus among Commissioners present that the log (a) should convey all pertinent info in a succinct manner and (b) does not need to include quoted content from correspondence or details of all intermediary actions, but should include a summary of information. The internal Public Works log is too detailed; an edited version will better suit the Commission's use.

There was also consensus that the log should include both (a) the degree to which the remediation satisfied ADA/legal requirements and (b) the degree to which the remediation satisfied the individual who reported the access issue.

3. Regarding the ADA Program Coordinator's template for courtesy letters to local businesses with reported ADA Title III violations, Chair Fischer objected to the sentence, "You have no obligation to respond to this letter, and the City of Berkeley is not asking you to take any actions." Chair Fischer noted that the letter already indicates the City "has no authority to enforce Title III of the ADA" and that the letter is a "courtesy." She believes that the City "not asking you to take any actions" sends the message that businesses do not need to take action, and works against the letter's intent to have accessibility issues corrected. Commissioners Pugh and Sun concurred.

### **Presentations**

 Ohlone Greenway Project: presentation by Public Works Project Manager Ken Jung.

The Commission asked that the presentation focus on safety concerns raised in the design and implementation of a shared-use path. The Commissioners strongly believe that the project's 2'-wide shoulders should be paved, except through the grove of trees in Cedar Rose Park, in order to provide 4' of additional, usable space. Commissioners pointed out that unpaved shoulders are unusable for many wheelchairs—and, for some wheelchairs, an area in which to become stuck. Unpaved shoulders are also a tripping hazard for disabled and older pedestrians. Widening the paving, by including (striped) paved shoulders, will result in a safer shared path.

The Commissioners asked that "share the path" signage and other communications designed for shared safety be submitted for Commission feedback while in the development phase.

2. California Commission on Disability Access (CCDA): presentation by CCDA Executive Director April Dawson.

There was consensus among Commissioners present that if/when CCDA and the City were to collaborate on a Berkeley-based event focused on ADA Title III requirements, the Commission would like to play a role in such an event.

It is covered by the Americans with disabilities act. I really hope the commission will take the song and stand up for what is what's the right thing and it's really the right thing to do to, not let people be hurt. The City of Berkeley guidelines, say, they must cell towers must be at least 300 feet away there are people becoming very disabled from five T I am one of them. But there are hundreds of other people in the direct area and the cell Tower at 1321 Gillman was put up illegally. No one was in 500 feet was notified by public works. I would like the commission on disability to take a look at this and it was included in the package. Thank you very much. Thank you for passing this on to chair person Fisher Mr. Gregory and have a good day.

I just want to remind her that it is you know, it is a D a because of the danger aspect and yes, she can email any letter to me to the Judy Blue my partner will print it out for me thank you for your help. But I really wish he would you know kind of wake up and and see what you're doing by supporting this without a separate path your be really putting people's lives on the line, not only disabled people, you know, I'm being a good Samaritan here. I don't want people who are walking around and normal like you. I think you are I don't want more non, disabled people to become disabled. It's horrible that more people will be injured and maybe killed because of these electric bikes in scooters going really fast there won't be any safe place for disabled people to be you know, I really wish you would look at that. I think it's very shameful that you're supporting this bad project. Yeah, so that's all I have to say. Thank you. You can send the email from the chair person in my email and I left him message last night for her also about the danger that the da da because of the danger aspect, please make sure she gets it thank you very much and about the five T it would be good if they can talk about that at the next meeting thank you.

He's the actual bike themselves are very heavy hundreds of pounds. They should only be on the street with the license like a regular vehicle it shouldn't be on a password pedestrians that's the danger and the attic and the danger aspect. It is covered by the 88, please pass that information onto chair person Fisher and here. It goes you can say the steer chair per person Fisher. This is Elizabeth Star regarding the aloni Greenway safety expansion plans. I believe the city attorney is wrong because these are not clearly only recreational vehicles. These are heavy motorized electronic bikes and scooters heavy Motors that I use for transportation and congested and pass, it should only be used on City streets with a license they absolutely should be nowhere where nowhere near a pedestrian adding the impact of danger to that's pedestrians makes it totally covered by the Americans with disabilities act, please reconsider coming out against this publicly. ### **Ohlone Greenway Project**

Dear Ms. Starr,

Thank you for bringing your concerns to the Commission on Disability. I am replying to this email address as it was used in one of your communications to the Commission.

After receiving your email and voicemails on the planned changes to the Ohlone Greenway shared path, the Commission heard a presentation from Project Manager Ken Jung at our September Commission meeting.

We voiced community and commissioner concerns regarding the safety of a shared-use path and discussed the unique challenge that the narrowest part of the Greenway path, through the grove of trees in Cedar-Rose Park, presents.

While we did not recommend against the project or that a separate ADA pathway be constructed, commissioners had concrete ideas that, we believe, will make the shared Greenway safer for everyone.

Most importantly, in order to provide four feet of additional, usable space -- and to avoid a tripping hazard -- the Commission strongly recommended that the projects planned two-foot-wide shoulders be paved. Required by guidelines, the shoulders were previously designed as unpaved. Commissioners pointed out that unpaved shoulders are a tripping hazard for disabled and older pedestrians. In addition, they are unusable for many wheelchairs and, for some wheelchairs, an area in which to become stuck.

This suggestion could increase the paved width of the path, through most of the project, by 20-30%. The Project Manager has confirmed that he is working with the designer to incorporate this idea into the design. Widening the paving, by including striped, paved shoulders, instead of unpaved shoulders, will result in a safer shared path for everyone.

In addition to the above design change, we have asked to look at "share the path" signage and other pathway safety messaging while in the design phase to improve the safety of a shared-use path.

While it is not be the outcome you seek, thank you for bringing this issue to the Commission's attention
