II. PROJECTS

- 1. 1598 UNIVERSITY AVENUE [at California] (DRCF2024-0004): Continued Final Design Review** to demolish an existing non-residential structure and construct a 134,409 square-foot, eighth-story mixed-use residential building containing 207 dwelling units (21 Very Low-Income unit) and 5,787 square foot commercial space, with 39 parking spaces and 92 bicycle parking spaces.

Final Design Review was approved with the following conditions and recommendations: MOTION: (Woo, Gaffney) VOTE (5-0-0-1) Tam – absent.

Conditions

- *Provide additional detail underneath the proposed parapet.*
- *Select an alternate for the proposed trees on the south property line that achieves the same screening intent in the Use Permit, but with increased fire safety.*

Recommendations

- *Modify ground surface at courtyard to reduce sound.*
- *Consider the design of the horizontal seams for the metal panels.*
- *Consider deeper window recess.*
- *Center-set glazing at storefront windows.*
- *Vents and grilles should be located in a regular pattern.*
- *Strong recommendation for bird safe glass, at least in the atrium.*
- *Reduce cultivars in plant list.*
- *For proposed vines adjacent to the sidewalk, increase soil depth and width (if possible) and the quality of the soil mix.*
