### **Mission Statement**

The Berkeley Youth Commission identifies the needs of youth, reviews and recommends youth services and programs.

Dear [BUSD School Board and Alameda County Board of Supervisors],

On November 8, 2016, Berkeley voters affirmed the power of the youth voice in politics by passing Measure Y1, an ordinance that would allow 16- and 17-year-olds to vote for members of the Berkeley Unified School District (BUSD) Board of Directors. In the more than seven years since its passage, Measure Y1 has yet to take effect. Today, on [insert date here], we ask that the Alameda County Board of Supervisors implement this measure.

The basic framework of our democracy relies on the principle that that which is elected by the people must be enacted by the government. With over 70% of the popular vote, Measure Y1 was supported by an overwhelming majority of Berkeley voters, and our [municipal/citywide] government must act accordingly to uphold the strength of our democracy.

Measure Y1 continues to be advocated for by groups like the Berkeley Youth Commission. Our mission is to identify needs among young people in Berkeley and make recommendations that reflect them. We believe this issue is of the utmost importance and urgency, as it secures youth representation on our local School Board. It encourages direct lines of communication between the School Board members and students, amplifying the youth voice in pressing and consequential decisions. It would further incentivize School Board members to legislate with BUSD students in mind. With voting power comes the ability to better advocate for programs widely supported by students.

Measure Y1 states that before its implementation, the City of Berkeley, the County Registrar of Voters, and the School District would likely meet and come to an agreement establishing the exact terms and conditions under which this policy would be implemented. We request that this meeting take place immediately, in hopes that measure Y1 can take effect before the 2024 general election. The BUSD School Board legislates on students' behalf, and we ask that our democratically attained representation not be denied.
